Introduction

This leaflet is for the parents and carers of young people who have been chosen to take part in Aimhigher Mentoring. As well as telling you about Aimhigher Mentoring it asks for some information about you and your child, to help us improve our activities and prove that what we do helps young people make the most of their educational opportunities. What is Aimhigher?

Aimhigher is a partnership of universities, schools and colleges. We aim to raise the aspirations and achievements of young people so that they can reach their full potential. Aimhigher delivers a range of activities for around 1,000 young people a year. We give young people a chance to explore different careers, find out more about qualifications and make the right decisions about their future. Aimhigher activities take place in schools, colleges, local universities or in professional workplaces like hospitals.

What is Aimhigher Mentoring?

The Aimhigher Mentoring Scheme involves undergraduate students (mentors) from local universities and young people in schools and colleges. The mentors support a group of five students on a weekly basis, usually for 12 to 15 weeks. Mentoring takes place during the school or college day, either one-to-one or in a small group. We also have a safe e-mentoring system that mentors and students can use at other times.

Aimhigher mentors help young people:

- raise their aspiration to succeed in their education
- improve their study skills, motivation, confidence, and time management
- explore different careers
- increase their awareness of higher education and decide if it is the right option for them.

Aimhigher Mentors are positive role models and our evidence shows that students benefit greatly from their support.

Safeguarding – taking care of young people

The safety and wellbeing of students is the highest priority for Aimhigher. All of our mentors undergo an enhanced Criminal Records Bureau / DBS check and are given full training and guidance in child protection. They work to a strict code of conduct which identifies their responsibilities for protecting young people.



Why do we need information from you?



To see how Aimhigher helps young people we need information from them and their parents or carers. We also need your consent to find out if your child goes on to gain their GCSEs, A levels or other qualifications and then apply for university. This is an important part of a research study we are undertaking, and involves asking learners that attend Aimhigher activities to complete questionnaires.

The form on this leaflet asks for your permission to use and match questionnaire responses with information on the Aimhigher Mentoring your child will receive, their exam results, school census data and information on what they go on to do after school.

How will we look after this information? – Data Protection

All information you give us will be held confidentially and each learner's name and school name will be held separately from the rest of the information. None of the information you give us will be shared unless you give us your permission. Any information we publish about Aimhigher will not identify you or your child unless you have given us your permission. Under the Data Protection Act 1998, you have the right to a copy of the data held about you by us, for a small fee. Data Protection
